DIRECTIONS

828 may be applied by foaming, high pressure washers or manually applied with brushes. Dilutions may range from using the product in full concentrate for the toughest of jobs, at 1 to 1 dilution for foaming or manual applications, 20-100 to 1 for applying through a high pressure sprayer. Apply or soak as needed. If residue is extremely thick, apply and allow to soak for up to 30 minutes. Rinse with water under pressure.
