Sentinel 207 HEAVY DUTY ADHESIVE & COATINGS REMOVER is uniquely formulated for removing wet and cured adhesives and coatings, including urethanes, epoxies, and PVAs. Sentinel 207 is a low-odor, fast acting product that cleans up with soap and water.

HANDLING AND STORAGE: Do not handle until all safety precautions have been read and understood. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Provide good ventilation in process area to prevent formation of vapor. Do not breathe mists. Keep away from sources of ignition-No smoking. Keep only in the original container in a cool, well ventilated place away from: Heat sources. Keep container closed when not in use.

DIRECTIONS

FOR SPOT CLEANING GLUES FROM NEWLY INSTALLED FLOORS:
Apply 207 directly to adhesive or wipe on with a saturated towel. Allow 207 to penetrate and soak into glue. Wipe residue away with a clean towel, or use a plastic putty knife to scrape away larger areas. Reapply 207 and wipe away any remaining adhesive. Use Sentinel 810 to clean flooring and remove any remaining remover.
FOR REMOVAL OF FLOORING ADHESIVES AND COATINGS IN LARGER AREAS:
Apply 207 using a mop or sprayer and let soak and penetrate until adhesive begins to soften. Scrape the bulk of adhesive up with floor scrapers. Reapply 207 as needed to remove remaining residue. Wash floor with Sentinel 810 and allow to dry completely.
