# REMOVER



## PRODUCT DESCRIPTION

SENTINEL 207W CARPET AND SHEET VINYL ADHESIVE REMOVER is the complete product for easily removing carpeting or for stripping the toughest latex and acrylic adhesives from all floor surfaces. The unique formula of 207W works quicker, clean and removes better and is easier to use than all other remover products.

## DIRECTIONS

### REMOVAL OF ADHESIVE

207W is a high strength adhesive remover and depending on the nature of the adhesive may be used straight or diluted 1 part 207W to 1 part hot water. First apply 207W to the adhesive to be removed. 207W will begin working in 20 minutes. Some adhesives make take as long as an hour. Once the adhesive is pliable, remove adhesive with a scraper blade or agitate with a stripper pad. To fully clean the floor, use a broom or stripper pad with rinse water. Allow overnight drying before reflooring.

### REMOVAL OF CARPETING

While 207W works on most latex, acrylic and pressure sensitive adhesives, it is recommended that you test a small area first. Cut the carpet to be removed into 1 foot strips. Mix 1 part 207W to 4 parts hot water. Pour the resulting mixture onto the carpet maintaining even coverage, depending on the nature of the carpet, coverage of about 25 square feet per gallon should be achieved. Allow to soak 1-4 hours, or overnight if preferred and proceed to pull up carpeting. Protect hands and feet from chemical. Scrape or agitate the adhesive with a stripper pad to remove adhesive from subfloor and rinse with water. Allow overnight drying before reflooring.

### REMOVAL OF SHEET VINYL BACKING

Remove wear layer. Mix 1 part 207W to 2 parts hot water. Apply mixture to the backing, desired coverage is about 30 square feet per gallon. (The backing absorbs the mixture slowly. It is preferable to apply the solution to wet the backing and in 30 minutes apply the remaining solution.) Allow up to 2 hours for the solution to penetrate and then scrape backing from the subfloor. To fully clean the floor, use a broom or stripper pad with rinse water. Allow overnight drying before reflooring.

FIRST AID: EYES - IF IN EYES: Rinse immediately and thoroughly, pulling the eyelids well away from the eye (15 minute minimum). Get medical advice/attention. SKIN - IF ON SKIN: Immediately rinse with water (for at least 15 minutes). Get medical advice/attention. INHALATION - IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician. HANDLING AND STORAGE: Do not handle until all safety precautions have been read and understood. Keep container closed when not in use.
