**DIRECTIONS**

Spray Sentinel 707 directly on area to be cleaned. Wipe clean with a disposable towel or damp cloth.

IMPORTANT: Sentinel 707 has been formulated with a slow evaporation rate to clean large areas of adhesive. Immediate wiping is not necessary.



**DANGER**

(Contains: Petroleum distillates, hydrotreated light, 2-( 2- butoxyethoxy) ethanol, Surfactant) May be fatal if swallowed and enters airways.

In case of fire: Use dry chemical, foam, CO2 extinction. Store in a well ventilated place. Keep cool.Store locked up. Dispose of contents/container to licensed waste handling facility.

Provide good ventilation in process area to prevent formation of vapor.do not breath mists. keep away from sources of ignition-No smoking. Keep only in the original container in a cool, well ventilated place away from : Heat sources. Keep container closed when not in use.
