This is a mild odor, economically priced mastic remover for removing black mastic on asbestos abatement jobs. This material does NOT contain asbestos.

DANGER

(Contains: Petroleum distillates, hydrotreated light, solvent naphtha, heavy aromatic, 2-(2-butoxyethoxy) ethanol, Surfactant) May be fatal if swallowed and enters airways.

If eye irritation persists: Get medical attention. **IF SWALLOWED:** Immediately call a POISON CENTER or doctor. If swallowed, do NOT induce vomiting. In case of fire: Use dry chemical, foam, CO2 extinction. Store in a well-ventilated place. Keep cool. Store locked up. Dispose of contents/container to licensed waste handling facility.

FIRST AID: EYES- **IF IN EYES:** Rinse immediately and thoroughly, pulling the eyelids well away from the eye (15 minute minimum). get medical advice/ attention. **SKIN- IF ON SKIN:** immediately rinse with water (for at least 15 minutes). Call a POISON CENTER or doctor/physician. **INGESTION- IF SWALLOWED:** Rinse mouth, Do NOT induce vomiting, Obtain emergency medical attention.

Provide good ventilation in process area to prevent formation of vapor. do not breath mists. keep away from sources of ignition-No smoking.
