This is a citrus mastic remover for removing black mastic on asbestos abatement jobs. This material does NOT contain as bestos.

DIRECTIONS

STEP ONE: Before beginning work, be sure to protect all walls, flooring, carpeting, cracks, or wood from liquid materials. This will ensure easier cleanup and eliminate potential problems. STEP TWO: Once the floor tile is removed simply apply product to the adhesive. This may be done by using a mop to evenly distribute the material Allow the material to soak and penetrate for 10-15 minutes.

STEP THREE: Using scrapers, remove the softened adhesive from the floor surface and reapply to the remaining adhesive residue. STEP FOUR: Using brooms or floor scrubbers, agitate resulting mixture and remove all liquids using absorbents.

STEP FIVE: Once the mastic and cleaner are removed, all residues may be completely rinsed by washing the floor with a Sentinel 805 EnviroWash and water solution.
