**Product Description**

Sentinel 922 Urethane adhesive Remover is a low-odor, biodegradable product designed to remove wet and recently cured urethane adhesives from pre-finished wood flooring, as well as facilitating the removal of damaged glued-down floors.

**Application Information** (Always follow product label instructions for best results)

**DIRECTIONS:**

**REMOVING URETHANE ADHESIVES**

**Step 1:** Protect walls, drains, cracks and other flooring with an absorbent. Wet the entire adhesive surface with 922, using a sprayer or mop. Allow 922 to soak and penetrate for 30-60 minutes, depending on the thickness of the adhesive.

**Step 2:** Scrape the bulk of the softened adhesive from the surface with a razor floor scraper.

**Step 3:** Reapply 922 and agitate using brooms or stripper pads. Liquefied adhesive can be absorbed using kitty litter (absorbent) and then removed.

**Step 4:** Wash and rinse floor thoroughly with Sentinel 810 and water to ensure a clean surface. Allow to dry thoroughly.

**REMOVAL OF GLUED DOWN WOOD FLOORING :**

**Step 1:** Cut the wood surface using a circular saw into 6" to 8" squares. Set the saw deep enough to cut through the flooring down to the subfloor.

**Step 2:** Vacuum all sawdust from the floor and cut lines.

**Step 3:** Apply liberal amounts of 922 to the cut lines using a squeegee or mop. Allow 922 to soak and penetrate under the wood for 4-8 hours.

**Step 4:** Using a spade or similar tool, pry up old wood flooring. Squares should be intact and easy to remove. Once flooring is removed, follow directions for removing adhesive from subfloor.

**COVERAGE:**

Expect coverage rates of 100-200 sq. feet per gallon on adhesive removal and 75 sq. feet per gallon on flooring removal.

**V.O.C. CONTENT:**

This Floor or Wall Covering Adhesive Remover contains less than 5% V.O.C. content by weight, in accordance with the requirements set forth by the California Air Resource Board (CARB) and Ozone Transport Commission (OTC), effective 1-1-2009.
