This is a mild odor, economically priced mastic remover for removing black mastic on asbestos abatement jobs. This material does NOT contain asbestos.

DANGER

(Contains: Petroleum distillates, hydrotreated light, 2-(2-butoxyethoxy) ethanol, Surfactant) May be fatal if swallowed and enters airways.

HAZARD STATEMENTS: Combustible liquid. May be fatal if swallowed and enters airways. Causes skin irritation. Causes serious eye irritation. Harmful if inhaled. May cause drowsiness and dizziness.

If eye irritation persists: Get medical attention. IF SWALLOWED: Immediately call a POISON CENTER or doctor. If swallowed, do NOT induce vomiting. In case of fire: Use dry chemical, foam, CO2 extinction. Store in a well-ventilated place. Keep cool. Store locked up. Dispose of contents/container to licensed waste handling facility.

FIRST AID: EYES- IF IN EYES: Rinse immediately and thoroughly, pulling the eyelids well away from the eye (15 minute minimum). get medical advice/ attention. Skin- IF ON SKIN: immediately rinse with water (for at least 15 minutes). Get medical advice/attention. Inhalation- IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician. Ingestion- IF SWALLOWED: Rinse mouth, Do NOT induce vomiting, Obtain emergency medical attention.

HANDLING AND STORAGE: Do not handle until all safety precautions have been read and understood. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Provide good ventilation in process area to prevent formation of vapor. do not breath mists. keep away from sources of ignition-No smoking. Keep only in the original container in a cool, well ventilated place away from : Heat sources. Keep container closed when not in use.
