PRODUCT DESCRIPTION

Sentinel Envirotowels for lead dust removal are the latest technology in cleaning and removing lead dust. They are designed to be used for pre-cleaning prior to removal or encasement and final clean-up following lead abatement. Each towel is ready-to-use and presoaked with a solution of Sentinel 805, a lead-specific cleaner that meets HUD Guidelines and Maryland Procedures. Each 290 pall contains 270 towels which are protected from contamination within the container.

DIRECTIONS

•Break tab on the side of the pall and remove the lid. From the center of the roll, pull up corner of the first towel, twist to a point and thread through the slot on the underside of the lid. Firmly push the lid back on the pall. Open cap on the pall lid and tear off towel at perforation.

FOR LEAD DUST REMOVAL:
Simply tear off towels at perforation and wipe all surfaces, ceilings, walls, floors, windows, doors, fixtures, cabinets, etc. until clean. Rinse if necessary.

CONTAMINATED TOWELS SHOULD BE DISPOSED OF ACCORDING TO FEDERAL, STATE, AND LOCAL REGULATIONS.

Envirotowels are also available in 90 count containers for use on smaller jobs or to keep handy in a tool box or vehicle.

Inhalation- IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician. Ingestion- IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Obtain emergency medical attention.

HANDLING AND STORAGE: Do not handle until all safety precautions have been read and understood. Wash hands and other exposed areas with mild soap and water before eating, drinking or smoking and when leaving work. Provide good ventilation in process area to prevent formation of vapor; do not breathe mists. Keep away from sources of ignition-No smoking. Keep only in the original container in a cool, well ventilated place away from: Heat sources. Keep container closed when not in use.
